

50th European Presidents' Conference 2022 in Vienna A.I.G.L.I. - Report - May 2022

During the Covid pandemic, A.I.G.L.I. had to abstain from its face-to-face congresses, which play a large part in facilitating relations between jurists from different nations and continents, all united by the ability and pleasure of speaking Italian.

For A.I.G.L.I., each personal meeting of the members is very important, because one of the aims of the statute is to promote and intensify relations between Italian-speaking jurists.

A.I.G.L.I., however, did not give up and made up for it by organizing both meetings on the Web and actual publications for which many members gave their scientific contribution.

Thus, for example, in June 2020 A.I.G.L.I. published "*La tutela esecutiva all'estero*", on the subject of the different systems for obtaining the forced execution of payment obligations, containing the comparison between the systems in Belgium, in England and Wales, in France, in Germany, in Italy, in Poland, in Spain and in Switzerland.

In September 2020, A.I.G.L.I. published "*Giuristi: spunti per riflessioni*", that we can translate "*Jurists: ideas for reflections*". It is a collection of reflections on the role of the jurist, of updates on some guidelines in 2020, of testimonies about the effects of the pandemic on the legal professions. In this case too, the contributions were from many countries: Austria, France, Italy, Slovenia, Spain, Switzerland.

On May 21, 2021, A.I.G.L.I. held a Webinar for its members on the topic "*Third party financing litigation*", with reports from Great Britain, Italy, United States, and coordination from Belgium.


On September 24, 2021, A.I.G.L.I. held a Webinar for its members on the topic "*Case law on the protection against discrimination*", with Italian moderator and reports from Germany, Italy, United States, Ukraine.

Now A.I.G.L.I. plans to release soon a rich publication (work in progress today) on the issue of the responsibility of the directors of joint-stock companies, thanks to the initiative and group work of members from the most different origins, from Brazil to Turkey, from the United States to Bulgaria, from Poland to Great Britain, from Germany to Italy and France, from Spain to Switzerland.

The harmony between the members, even if they are far away, demonstrates how beautiful and fruitful peace and collaboration are, while respecting differences.

The wish for the next event, this time in presence in 2022, is that it can take place in an atmosphere of peace and serenity.

We will do our best in A.I.G.L.I.
