# Contributions to EU Law-Making

### **Ongoing Projects**

The EYBA is contributing to the regional project "Strengthening the profession of lawyer in line with European standards" by supporting the youth in the legal profession in the 5 EaP countries (Armenia, Belarus, Georgia, Moldova and Ukraine), funded by the European Union and the Council of Europe.

The EYBA in cooperation with the Council of Europe HELP Programme and the European Association of Lawyers (AEA-EAL) has implemented a free on-line **HELP Course "Ethics for Lawyers"** for a group of lawyers from EU and non-EU countries.

#### **EYBA Task force for Ukraine**

The EYBA has created a list of 150 lawyers expert in migration law, refugee law and human rights, in the European countries, that are available to give advice for the Ukrainians who are currently outwith the country seeking protection.

The EYBA, following the resolution on **Empowering European Youth** in the context of the European Year of Youth and our society postcovid, has launched a **survey** among its members in order to:

- collect the national rules (laws or code of conducts) regarding legal traineeship (focused on the remuneration) specifying if those rules are mandatory or not, and if there is any remedy for a young legal trainee with respect to violation of the rules;
- evaluate if those rules are respected in practice (whether or not they are mandatory) or if there is still a phenomenon of "exploitative practices".

#### OUR ACTIVITY WITH THE COUNCIL OF EUROPE

The EYBA is allowed to attend sessions of the Conference of INGOs, propose motions and vote. The EYBA presence and active participation in the works of the CINGO aligns with one of its key statutory purposes: support human rights across Europe.

The EYBA representatives have attended the 2021 and 2022 sessions of the Conference of INGOs, contributed to the Statement related to the "Migration and tension on the Polish-Belarusian border" and participated in the public consultation for the future legal framework in Artificial Intelligence (AI). Moreover, a member of the EYBA executive committee has been appointed in the INGO-SERVICE of the Conference of INGOs.

The EYBA organises since 2020 a Call for applications to its members who wished to attend, as "youth delegate", both sessions of the Conference of INGOs of the CoE. Our youth delegate attended the 2021 sessions of the Conference of the INGOs and the World Forum for Democracy in Strasbourg in November 2021.

A new call for applications has been launched for 2022.
