Regulation and Defense of the Profession

- The CGAE succeeded in getting the European Parliament to continue studying and addressing the situation.
- The PETI Committee: ***"We urge the continuation of constructive dialogue aimed at solutions that are fully in line with European Union legislation, policies, and recommendations."***
- The CGAE has asked the Spanish Parliament to speed up the processing of the reform that will enable mutual society members to transfer to the RETA (Special Scheme for Self-Employed Workers)

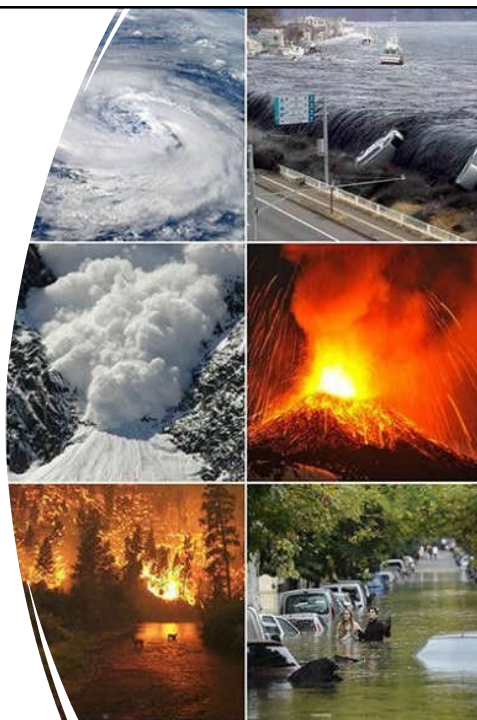


Crisis management for natural disasters



The legal working group of the Special Commission of Unión Profesional, coordinated by the General Council of Spanish Lawyers, aims to develop proposals for the prevention of and response to natural disasters.

It will include measures of interest to the profession, such as the regulation of the suspension of procedural deadlines.



CGAE in Europe



European reports published in 2025 reflect **progress in efficiency, digitization, and access to justice.**

The 2025 EU Justice Scoreboard ranks Spain as the country with the second most procedural rules allowing digital technology in courts in civil/commercial, administrative and criminal cases.

CCBE

- CCBE issued a statement on Spain's proposal in support of the Rule of Law & the need to protect judicial independence and fundamental rights
- Several milestones were achieved in the CCBE through the Committees where Spain holds the presidency: drafting of a Guide for lawyers on the New Pact on Migration and Asylum & participation in the High-Level Forum on the future of EU Criminal Law.
- With Noemí Alarcón newly elected Vice-President of the CCBE, the CGAE will contribute to the priorities and values of the EU for lawyers in the European agenda.



- The Spanish Bar Association, which until now held the presidency of the International Observatory on Lawyers at Risk, has transferred it to the Consiglio Nazionale Forense.
- The Foundation's XII Annual Human Rights Congress addressed the defense of lawyers at risk. The prizes were awarded to:
