Founded in Luxembourg 40 years ago, the **European Lawyers' Union (U.A.E.)** is a non-profit association bringing together legal professionals from across Europe.

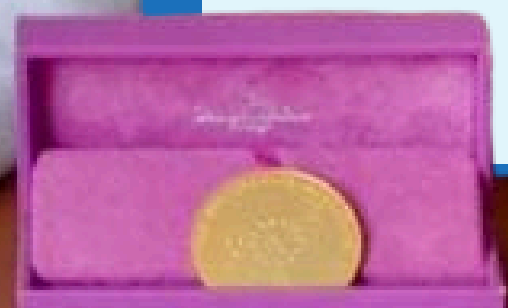
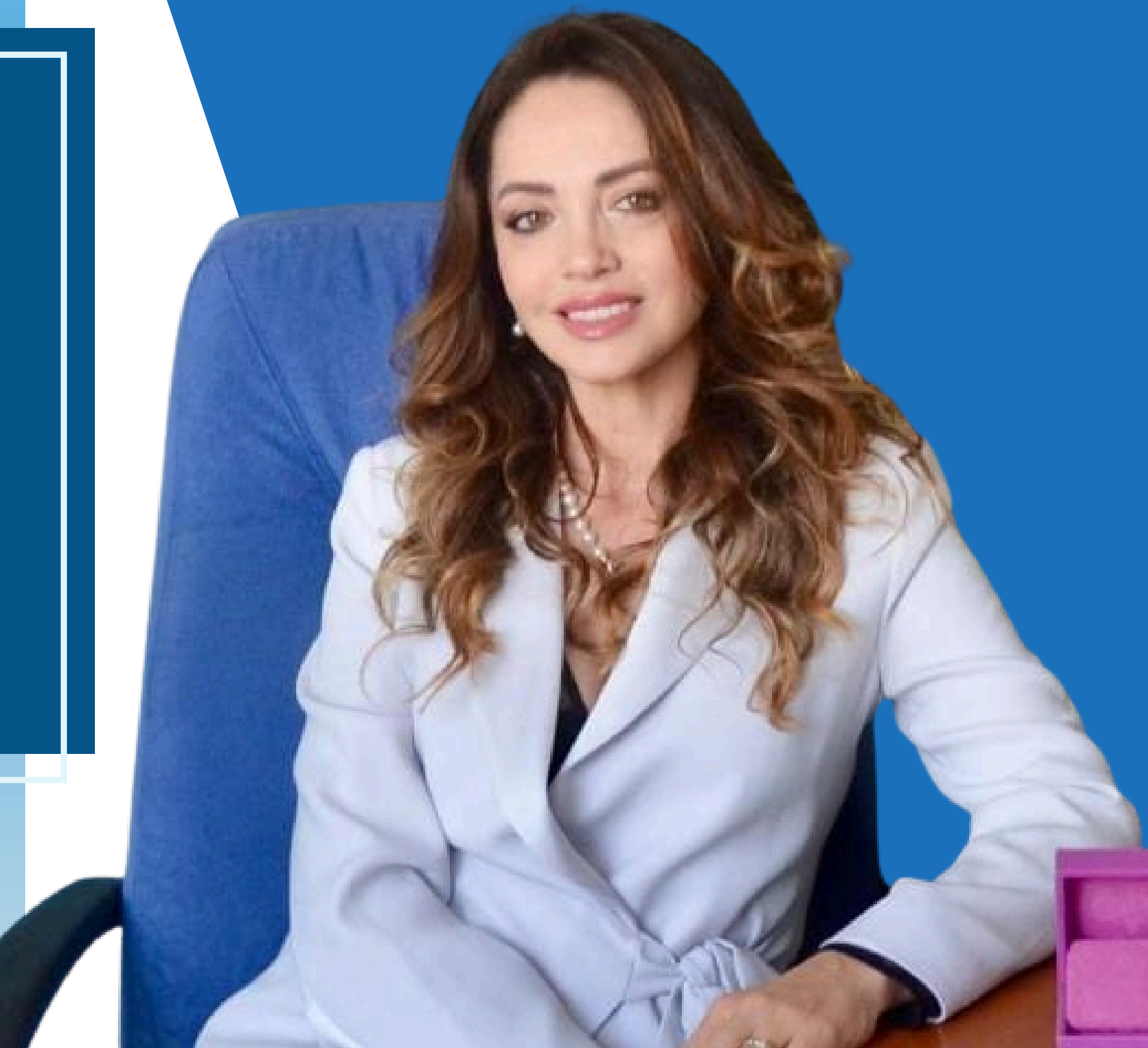

We had the privilege of being hosted by the Council of Europe for the Conference on **Business and Human Rights**, as part of the annual **General Assembly** of the U.A.E. Our speakers were Judges of the European Court of Human Rights and members of the Council of Europe. The case for business and human rights is underpinned by the 2011 United Nations Guiding Principles (or UNGP).

In 2016, the Committee of Ministers of the Council of Europe adopted a Recommendation CM/Rec(2016)3 on human rights and business, a text that provides more specific guidance to help member states prevent and remedy human rights violations by commercial enterprises and also insists on measures to induce enterprises to respect human rights.

Moreover, the European Union has been defined as a key player in the global landscape of human rights protection in business, taking the lead with regard to sustainability and due diligence standards (according to a September 2025 report by the Council of Europe on human rights and competitiveness); and it could not be otherwise, considering that the protection of human rights is one of the main objectives of the European Union.

This event was also attended by the leaders of the Kuwait National Bar and their international relations committee.

The President of the U.A.E. signed a memorandum of understanding with the President of the Kuwait National Bar aimed at ongoing dialogue on European and Kuwaiti legislation and legal practices, as well as the exchange of information on developments in the legal systems of each country.

The right to housing, however, is equally essential: it represents the basis of human dignity, security and social participation.



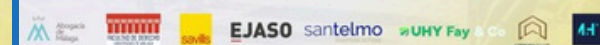
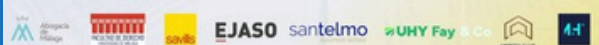

The challenge is not to choose between property and housing, but to build tools that allow both to coexist in a sustainable way.

Italy

The issue of gender gap has been at the centre of our conferences and debates in Italy.

The president was also invited to talk about it on an Italian television programme on Rai Uno, the main public television broadcaster, as part of an in-depth discussion on the subject.

The gender gap is not an abstract concept, but a concrete distance that prevents men and women from living in a truly balanced society, where opportunities do not depend on gender but on talent, choices and real possibilities.

The top five European economies – Iceland, Finland, Norway, Sweden and Germany – all rank in the top 10 worldwide in the global gender gap index; nevertheless, it will take 134 years to achieve full equality worldwide.

This means that although many countries have laws guaranteeing equal rights, the reality of everyday life tells a different story: wage differences, unbalanced care burdens, under-representation in decision-making roles, stereotypes that influence educational and career choices. Substantive equality requires cultural change, not just regulatory change.

We believe that talking about it is part of the solution. The fact that it will take over a hundred years should not discourage us, but rather encourage us to remain vigilant. Every time we discuss the gender gap – in schools, in the media, in businesses, in politics – we help to highlight what is often taken for granted. Awareness is the first step towards changing behaviours, laws and social structures.

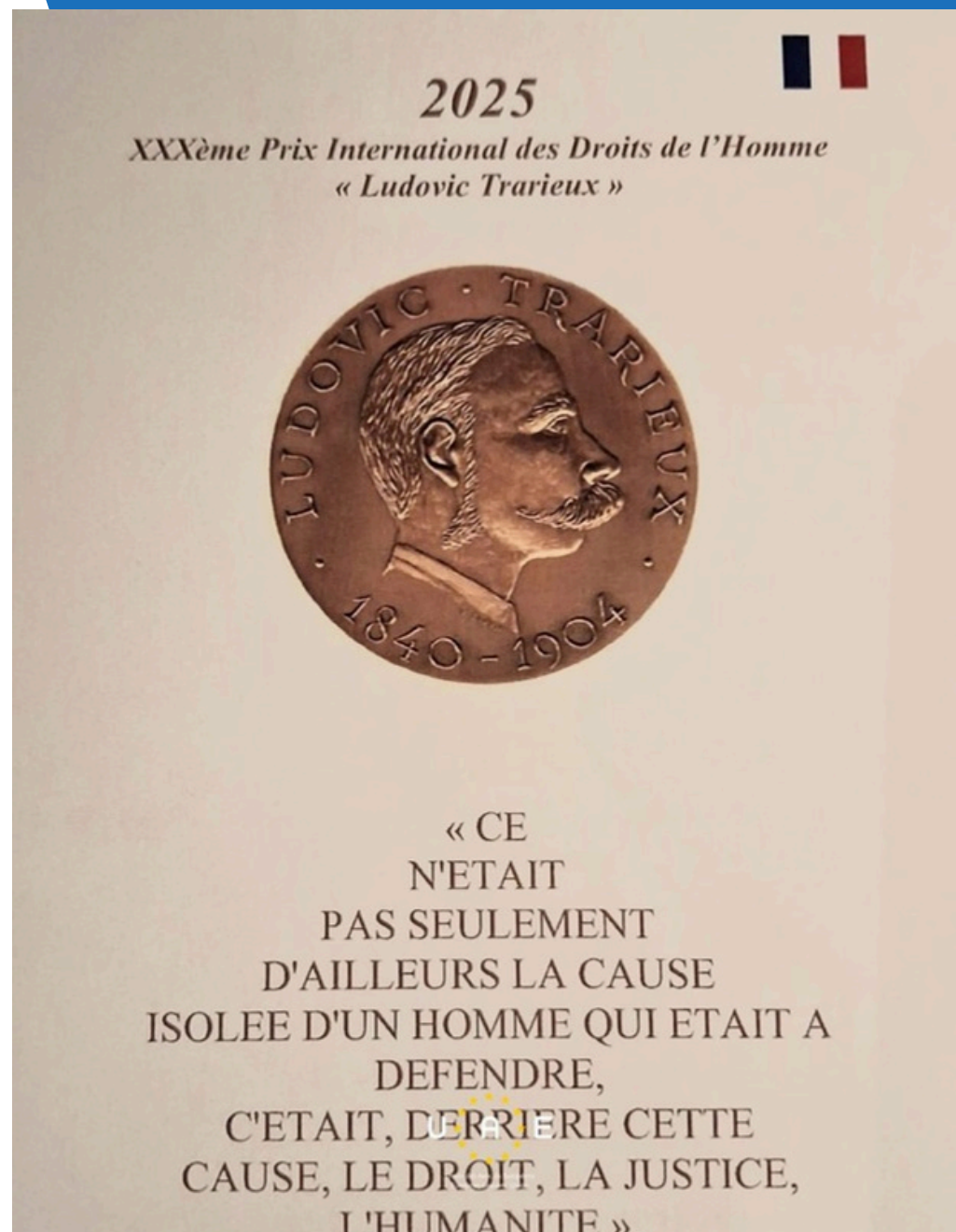

With regard to international relations, in addition to signing the MoU with the Kuwait National Bar, we are receiving interest, which we are reciprocating with pleasure, from some Asian countries that demonstrate an interest in our values, particularly the protection of human rights, as well as from some South American countries, including Argentina, whose Ambassador to Italy hosted us at the embassy in Rome to launch a project for collaboration and sharing of important legal issues.

President Rosanna Marzocca was also invited to attend the event organised at the French Senate for the presentation of the Ludovic Trarieux Prize, which for 40 years has been awarded to lawyers who have distinguished themselves in the protection of human rights and which this year was awarded to Russian lawyer Dimitri Talantov and the Istanbul Bar Association.

Ultimately, our vision of the legal profession is closely linked to the social function that lawyers perform in civil society. In fact, lawyers are not only legal experts, but also guardians of democracy.

Their social function is not limited to legal representation: it is a role that lives in society, in the culture of rights, in the defence of freedoms when they are threatened.

The role of lawyers extends beyond the judicial system, contributing to the defence of freedoms and equality as collective values.
